- 12) Respect the play structures, equipment, toys, and others.
- 13) No toys on the active structures or slides.
- 14) Please leave personal toys at home or outside the play center.
- 15) Please listen to ABOF staff and follow additional safety rules as directed and/or explained.
- 16) No returning to play area after the party begins in your private party room.
- 17) No food, drinks, sippy cups, pacifiers or bottles allowed in play areas
- 18) No party celebrations allowed in the snack area.
For safety reasons, A Bunch of Fun reserves the right to refuse admittance to the center if the number of persons exceeds capacity.
